## Board Contract

### Read the Terms and sign the contract if you agree to ALL the Terms:

1. Board is due on the first of each month. There will be a grace period until the 3rd of the month. If board payment is not received by the end of the 3rd day of the month then a \$20.00 late fee will be added and \$5.00 for each day it is late after that. Late fees are due immediately upon receipt of the late board payment and will continue to accrue if not paid.

2. Board includes ONLY what is listed below:

Full Board includes: Daily turnout (weather permitting), daily stall cleaning, feeding of hay and grain 2-3 times per day, Nutrena SafeChoice grain up to 6lbs/day, hay up to one 40 lb. square bale or equivalent/day, bedding up to 12 bags/month, blanket changes due to temperature change, booting & fly masks for turnout (pull-on bell boots will be left on), supplements and/or medications supplied by Horse Owner will be added to horses feed as instructed, farm supplied fly spray applied by HHF staff member for turnout only (you must have your own fly spray if you want to spray your horse for riding, etc), trace mineralized salt blocks provided, use of the Indoor and Outdoor Arena, surrounding trails, XC jump fields (ground person required for XC jumping - see Rules), space to store 1 saddle, 1 bridle and 1 trunk. Any additional items/care will be charged on a per item basis according to the farm Service Fees Chart.

Recovery Board includes: All the items & limits listed in Full Board, except turnout will be based on horses condition and vet recommendations. The monthly charge is higher to account for additional work/time constraints due to limited turnout times, additional stall picking/cleaning needed if the horse is in more hours of the day than usual according to farm standards. Also, additional charges will be added on an per item basis according to the farm Service Fees Chart. This will depend upon how involved the owner is in the additional care required for their horse and how much care the horse requires.

Pasture Board includes: Shelter, water, unlimited access to pasture or round baled hay, grain fed 1-2 times per day, Nutrena SafeChoice grain up to 3 lb. per day maximum, space to keep 1 saddle, 1 bridle, and 1 trunk, use of arenas, XC course and trails.

3. Horse Owner must give one month (30 days) written notice before terminating this board contract for any reason. Horse Owner must pay board through the end of the 30 days (one month) notice even if they remove the horse before the end of this 30 days. Hogback Hill Farm must give the Horse Owner 30 days notice before terminating boarding arrangements or changing the Board Contract for any reason.

- 4.** Deposits for stalls/space to be held are to be made for one month's board rate. Deposits are NOT refundable. The deposit will be used for Horse Owner's first months board.
- 5.** A regular veterinary, de-worming and farrier schedule will be maintained by the Horse Owner and any pertaining services/products paid for by the Horse Owner. Hogback Hill Farm can arrange for and carry out these services for you according to the farm Service Fee Chart. All vet and farrier bills will be paid by the Horse Owner.
- 6.** In the event of sickness and/or injury to the horse, after reasonable efforts to contact the Horse Owner have failed, Hogback Hill Farm has permission to contact a veterinarian for any necessary treatment for the horse and the veterinarian bill will be paid for by the Horse Owner.
- 7.** The Horse Owner verifies that the horse is free from infections, contagious or transmissible disease and will submit a current negative Coggins test and veterinary record of vaccinations before or at the arrival of the horse to Hogback Hill Farm.
- 8.** It is the responsibility of the Horse Owner to carry full insurance coverage on their horse and all personal property.
- 9.** The Horse Owner assumes all risk and responsibility for the loss or damage to the horse and all personal property due to theft, fire, or any other casualty and agrees to hold Hogback Hill Farm and its employees or agents harmless from all damages occasioned by same.
- 10.** Equine Activities by their very nature are risky and dangerous. The Horse Owner agrees to assume all liability for injury or death that may occur during participation of riding or unmounted activities involving horses or not at Hogback Hill Farm and its surrounding areas such as roads and trails.
- 11.** Any additional person(s) who have permission of the Horse Owner to ride/handle the horse must sign a Hogback Hill Farm Release Form before participating in any equine activities at Hogback Hill Farm. The Horse Owner must also provide permission in writing, dated and signed, for the additional person(s) to ride/handle the horse. Horse Owner agrees that Hogback Hill Farm is not responsible for governing the activities of the additional person(s) or any accident or injury that may occur to the horse when the additional person(s) are interacting with their horse.
- 12.** Enforcement of the penalty or payment type terms in paragraphs 1, 3 and 4 is at the discretion of Hogback Hill Farm. Non-enforcement in a specific instance does not indicate a waiver of that or any penalty or payment type term in the future.

## Board Contract

### Rules:

1. Riders under 18 years of age must wear a helmet that meets currently accepted ASTM standards and is SEI certified at all times when mounted. We encourage ALL riders to wear protective helmets.
2. In order to maintain a peaceful atmosphere for all please do not bring dogs and small children to the farm.
3. Barn hours are 8:00 a.m. to 9:00 p.m. Please be ready to leave by 9:00 p.m.
4. NO SMOKING in or near any of the farm buildings. Please do not litter cigarette butts anywhere on the property, make sure all cigarettes are completely extinguished!
5. Please clean up after yourself and your horse. Keep your items in a tidy fashion.
6. Everyone involved with equine activities on the farm, mounted or not, MUST have a signed release form on file before engaging in such activities. No exceptions.
7. For the general health of the herd, all horses must be kept on a regular farrier, veterinary (vaccinations) and de-worming schedule.
8. The barn phone is generally NOT for boarder use. Boarders may use it in the case of an emergency or in the instance of waiting for the vet or farrier ONLY.
9. No food or beverages are to be left in or near the barn. This also must include the barn trash barrel. In order to avoid rodents and insects in the barn, please take wrappers, soda cans, etc. home to dispose of.
10. Only use your own equipment, tack and supplies. Please respect the property of others.
11. DO NOT feed treats (or anything — hay, grain, etc.) to any horse except your own. Horses may have allergies, special dietary requirements, etc.
12. Do not leave horses unattended tied, cross-tied, etc.
13. Any person who will be jumping any XC jumps (solid obstacles) MUST have a ground person and wear a safety crash vest and helmet that meets currently accepted ASTM standards and is SEI certified. No exceptions.
14. There is to be NO TURNING OUT HORSES in the Outdoor Arena, Indoor Arena or Round Pen.
